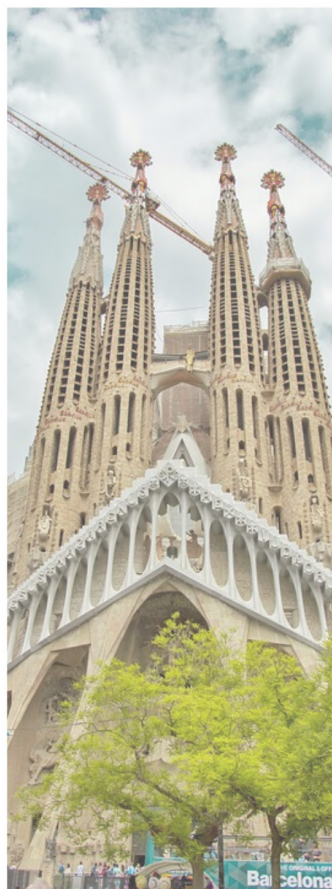
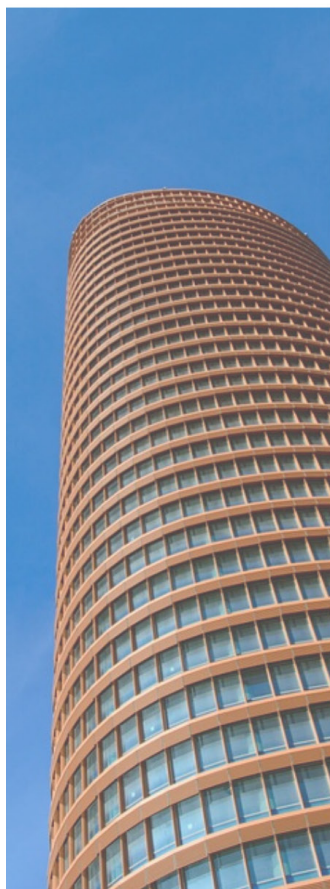

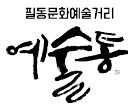

We want this moment to be a turning point so that our bilateral relations may reach its real potential in all areas. We rely on your support to achieve all these goals.

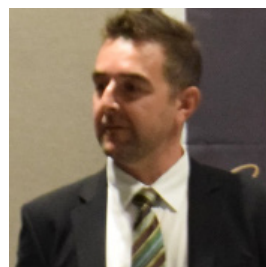

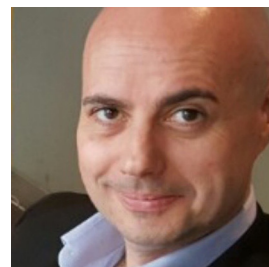

# GENERAL INFORMATION

Spain is located in the south west of Europe. The largest part of the territory is located in the Iberian Peninsula, the remainder, approximately 12,500 square kilometres, are islands -Balearic and the Canary Islands-, plus 32 square kilometres that are accounted for by the cities of Ceuta and Melilla, situated on the coast of Africa.

Its location endows Spain with a great strategic value: projecting into the Mediterranean on one side and acting as an intersection on the path to Africa and America.

Its position also offers Spain with different climates: mild oceanic climate in the North, continental Mediterranean at the centre and Mediterranean in the East and South.

---



Spanish culture is extremely rich and touches upon all forms of artistic expression. From literature to painting, music to architecture, the theatre to sumptuary arts.

In each of these aspects, at some time in history or other, Spanish culture has reached the highest artistic heights: from bygone times until present day, culture and art in Spain are prominent features of the country.



# INVESTMENT IN SPAIN

---

Spain is in an outstanding position worldwide in terms of the importance of its economy: the 14th largest economy in the world by GDP, the 13th country most attractive for foreign direct investment (FDI), the 14th largest issuer of FDI and the 11th largest exporter of commercial services. There are interesting business opportunities for foreign investors in Spain in high value-added and strategic fields such as the ICT, renewable energy, biotechnology, environment, aerospace and automotive sectors.



In addition, companies that set up business in Spain can gain access not only to the Spanish national market, an attractively large market (more than 46 million consumers) with a high purchasing power, but also to the markets of the EMEA region (Europe, Middle East and North Africa), and Latin America, given its privileged geostrategic position, prestige and the strong presence of Spanish companies in these regions.

# INVESTMENT IN KOREA

---



South Korea is Spain's third export market in Asia, outside the Middle East, after China and Japan.

Korean market offers very good opportunities for Spanish companies in various sectors. The processed agri-food products (from quality wine and other beverages, to olive oil and gourmet products, or meat) can be highlighted; consumer goods that incorporate design and high quality (fashion, shoes, home, furniture); industrial products could include

those related to energy, including renewables, automobiles and components or machinery. There are notable opportunities in innovation, taking advantage of the high technological capacity of Korean companies.

IMF calculates the potential growth of the Korean economy at around 3% for the upcoming years. The Free Trade Agreement with the European Union entered into force from July 2011 and resulted in practical disappearance of tariffs for most of Spain's export products.
